The school will follow the syllabus on the basis of curriculum prescribed by NCERT/CBSE and text books publishing by NCERT/CBSE for the Middle Classes. The school will follow syllabus and courses as per scheme of studies prescribed by the Board for Secondary/Sr. Secondary School Examination and changes made therein from time to time.

The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt from time to time.

The school will enroll students proportionate to the facilities available in the school as prescribed in the Affiliation Bye-Laws of the Board which shall not in general exceed the optimum number as under **from Pre-Primary to Class XII** :-


meeting the salary cost and its component towards teaching and non-teaching staff appointed by the Managing Committee.



Sub : General Sanitation & Drinking Water facility of the school.

Sir/Madam,

I visited your school with Dr. B.P Debata (DSMO), Angul, Dr. Binod Kumar Sahoo (Epidemiologist) and District Task Force Team on Dt.25/09/2013. on my visit I observed the sanitary condition and Drinking water facility of the school as follows :-

1. The school is situated At – Patabeda, P.O/P.S: Pallahara from Angul Town at about 95 K.M distance in good environment. The school is having three hundred forty two students.
2. The school premises were clean and tidy.
3. Four Numbers of sweepers have been appointed for daily sweeping and cleaning the school rooms, Toilet, Latrine, Hostel and School Premises.
4. The solid waste are disposed in side of the school compost pit.
5. No. bushes, unwanted plants found in side the school campus.
6. The class rooms are well placed & ventilated.
7. There are separate Toilets for students and Staffs. The Toilets & Urinals are also separately made for boys & girls. The Toilets & Urinals are well maintained.
8. There is a bore well in the school premises with three numbers over head tanks and its surrounding is good & clean. Supply of safe drinking water for all students from the bore well again purified by Aquaguard.
9. The water source is sufficient for existing strength of children's & staffs.
10. The water of the said bore well is odorless & good in taste.
11. There is one separate kitchen and dinning room for hostel students.
12. Two Nos. of female cooks engaged in the kitchen for preparing food for students.
13. There is no compound wall of the school campus. It is suggested to construct the compound wall as soon as possible.
14. There are four nos. of fire extinguisher fixed up to prevent fire accident.

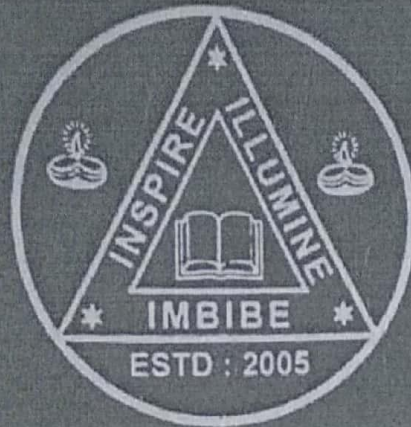
